WHAT IS CERTIFICATION?

Certification is the provision by IRMSA of written assurance that an individual in question, meets specific requirements.

It is the formal attestation or confirmation of certain characteristics of that person.

To become certified, you need to be an Associate Member.

Below are the requirements for becoming an Associate Member:

- Relevant qualification (NQF level 6) + 5 years risk management experience.
- Risk qualification (NQF level 6) + 3 years risk management experience.
- No formal tertiary qualification + 10 years risk management experience.

Once you become an Associate member you can follow a professional career path by writing the IRMSA Board Exams to obtain the Certified Risk Management Practitioner (CRM Prac) and Certified Risk Management Professional (CRM Prof) designations.

Below are the requirements to qualify for the CRM Prof designation:

- No formal tertiary qualification + 15 years risk management experience.
- Relevant qualification NQF 8 + 10 years risk management experience.
- Risk Qualification (NQF level 8) + 5 years risk management experience.

Management Practitioner (CRM Prac):

specialised background and expertise in risk management.

The certification validates that the individual possesses a foundation level knowledge and experience to implement and manage an organisation's risk management programme under supervision.

Certified Risk Management Professional (CRM Prof)

The CRM Prof Designation is a strategic level certification designed for individuals who have a specialised background in risk management. The certification validates that the individual possesses a comprehensive level of technical knowledge and experience required to assess, implement, and manage an organisation's risk management programme without supervision.

- Professional status- Independent recognition of professional status by South African Qualifications Authority (SAQA)
- Recognition as an expert in the field

Ask yourself the following important questions before applying:


- Do I meet at least 70% of the logbook requirements?
